ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. The "Sensible Portions Summer" contest (the "Contest") begins at 12:00:00 noon Eastern Time ("ET") on Monday, May 14, 2018 and ends on Sunday, August 19, 2018 at 11:59:59 AM ET (the "Contest Period"). There are two (2) parts to this Contest: (a) one (1) Grand Prize Sweepstakes draw from all eligible entries received between 12:00:00 noon ET on Monday, May 14, 2018 and Saturday, August 18, 2018 at 11:59:59 AM ET (the "Grand Prize Period"); and (b) fourteen (14) Secondary Prize draws, where one (1) Secondary Prize will be available to be won from the eligible entries received during each period as listed in the chart below:

2. **ELIGIBILITY** Contest is open to legal residents of Canada who have reached the age of majority in their Province or Territory of residence as of the date of entry. Excluded from eligibility are officers, directors, employees, agents and representatives of Hain Celestial Canada, ULC ("Sponsor"), each of their respective advertising agencies, promotional agencies, fulfillment houses and prize suppliers, each of their respective parent, affiliated and related companies, agencies, suppliers of the materials and services related to this Contest, and members of the immediate families (defined as parents, siblings, children and spouses, regardless of where they reside) or households (whether or not related) of such officers, directors, employees, agents and representatives.

3. **HOW TO ENTER NO PURCHASE NECESSARY.** Internet access required. During the Contest Period enter through the contest Microsite at spsummercontest.com (the "Contest Website"). To participate, submit your entry by filling out the entry form and clicking on "Submit". All fields must be completed unless indicated as optional. You will be required to provide your first and last name, address, email address, and phone number. **LIMIT:** One entry per person per day. Each entry must be submitted by the entrant himself or herself. Entrant may only use one (1) email account and one mailing address in connection with the Contest. Each entry is subject to verification. Duplication, or any attempts to exceed the maximum number of allowable entries per person is a violation of these Official Contest Rules and may result in disqualification. Use of automated devices is prohibited;

automated entries (including but not limited to entries submitted using any robotic, script, macro, or other automated service) are not permitted and may result in disqualification.

4. HOW TO WIN

A. GRAND PRIZES On August 27, 2018, at 2:00 PM ET in Oakville, Ontario, two random draws will be conducted from all eligible entries received during the Contest Period. The odds of being selected as eligible to win the Grand Prizes (as defined in Rule 5A below) will depend on the total number of eligible entries received. If you are selected as eligible to win one of the Grand Prizes, you will be contacted by email by the contest judging organization on the draw date at the email address you provided when you registered. See prize claim conditions in Paragraph C below.

B. SECONDARY PRIZES In each Secondary Prize Period, one Secondary Prize (as defined in Rule 5B below) will be available to be won. The schedule in Rule 1 sets out the beginning and ending date and time for each period throughout the Contest Period. For each period, a random draw will be conducted from all entries received during the applicable period (see Rule 1). Entries that are not selected as a potential winner during any given period will be carried forward into future draws. Odds of being selected as eligible to win a Secondary Prize will depend on the number of eligible entries received during the applicable period. If you are selected as eligible to win a Secondary Prize, you will be contacted by email by the independent contest judging organization on the draw day identified below, at the email address or telephone number you provided when you registered. To receive the travel credit (up to a maximum \$4,000 value), winner(s) and/or the RV rental company must show the contest administrator valid travel/booking confirmations and receipts. The funds will be either paid directly to the travel agent or RV rental company or reimbursed back to the winner(s) if a valid invoice is produced to the contest administrator.
